Nor will I be allowed to know the dog's whereabouts although I may visit the rescue site and sometimes updates and pictures are posted about the dog. My relinquishment of said dog is in exchange for said dog to enter the Canaan Dog Rescue Network for evaluation and placement. I agree and understand that said dog is now "sole property" of the Canaan Dog Rescue Network. I do hereby give authorization to the Canaan Dog Rescue Network to obtain all veterinary records on said dog. I promise that the information that I am giving is accurate and that the Canaan Dog Rescue Network will not be held liable or chargeable for any false information or any misrepresentations that I may have submitted on this form. I also sign this surrender agreement honestly and truthfully that said animal has never bitten any human being. Should said dog pose a danger to itself or anyone else, I do hereby fully understand that the Canaan Dog Rescue Network will have the authority to euthanize said dog if necessary to prevent it from endangering anyone, and I will not be notified per my agreement to relinquish said dog to rescue.

No Guaranties. We make no representations or guaranties about our arrangements for the dog.

No Liability. We are not liable to you for any losses, injuries, damages, costs, expenses or liabilities whatsoever sustained or incurred by you in connection with your surrender of the dog, and our subsequent adoption, foster, or other arrangements for said dog.

Entire Agreement/Modifications/Binding Effect. This written Agreement contains the sole and entire agreements between the Canaan Dog Rescue Network and you, and supersedes any other agreements between you and us with respect to the subject matter of this Agreement. No modifications of this Agreement will be valid unless in writing duly signed by both you and us. This Agreement will be binding on our and your respective heirs, assigns, successors, personal representatives and executors.
